the redan

HOLE #1

The Redan features a green that slopes from the front right to back left, with a large hump on the front right of the green to help balls roll back. This forces players to aim away from the center of the hole in order for the ball to end in the proper position.

the devil's hole

HOLE #2

The Devil's Hole showcases a green located on a sandy hill knoll, offering little room for mistakes. From the mythical bunker, the only possible escape is playing backwards.

the queen

HOLE #3

With a setting that perfectly complements the natural environment of Mandarin, The Queen offers high sand dunes and land rolls that recreate the soul of the links courses. The diagonal orientation of the green clearly shows each of the surrounding bunkers, which can be quite dangerous and difficult to escape.

the theater

HOLE #4

The moment you step onto the tee box of The Theater, you know you've arrived at one of the world's best mid-length par threes. The green is set on a hill that forms a natural amphitheater and is surrounded by large bunkers, steep slopes, rolls, hills and depressions that result in one of the most artistic holes in the golf world.

the pot bunker

HOLE #5

The Pot Bunker boasts a green with two main playing areas—the lower, front-right quadrant surrounded by “receiving” slopes and the flatter, upper plate at the back left—with twisting transitions connecting the two tiers. The central bunker, one of the most unique hazards in golf, represents an island pot bunker surrounded by green.

the links stamp

HOLE #6

The Links Stamp commences with a tee positioned on high ground that leads to a long yet extremely narrow green set into the side of a large sandhill. Two bunkers protect the left side of the green, while a large crater bunker shields the approach. Any mistake on the right will find one of the two deep bunkers with near vertical faces.

herradura

HOLE #7

With the Pacific Ocean as your backdrop, Herradura tees off from an elevated vantage over a ravine to a square green-ringed with sand and deep interior horseshoe-shaped punchbowl, all set within an inverted sand horseshoe.

barranca

HOLE #8

Barranca requires no more than a short iron across, yet the yawning bunkers that spill into the barranca that front the green creates one of the most dramatic approach shots on the course, with the large green bringing dramatic contours.

the bell

HOLE #9

A daunting water presence and strategically placed bunkers make it imperative to land your shot on the putting surface at The Bell. A beautiful walk from the tee to the green immerses you in the natural beauty of Mandarin.

the kraken

CHALLENGE HOLE

One of the most challenging design concepts of island greens comes to life at The Kraken, mimicking the short-length par three with a wide green that narrows along the right side. A small pot bunker offers a welcomed relief to those who fall short of the green.
